

Flex Your Profit Terms and Conditions

1. Introduction

These Terms and Conditions ("**Terms**") govern the Flex Your Profit ("**Promotion**") offered by Vantage Global Limited ("**Vantage**" or "the **Company**"), a company registered with the Vanuatu Financial Services Commission (VFSC) under Registration No. 700271. By participating in this Promotion, you acknowledge and agree to comply with these Terms.

2. Promotion Period

The Promotion is available from 16 December 2024 to 20 December 2024 ("**Promotion Period**").

3. Eligibility

The Promotion is open to clients who meet the following criteria:

- Must be part of Vantage Plus official Telegram community;
- Must have a Live STP/ECN account with Vantage; and
- Must be a resident of Eligible Countries/Regions.

4. Participation Requirements

- Join Vantage Plus Official Telegram group;
- Make a winning intraday trade;
 - Intraday trades with losses will not be counted towards this Promotion.
- Create a share banner from the Vantage App of the winning intraday trade (Refer to Appendix);
- Share the banner in the Vantage Plus Telegram #Chat-General group and hashtag #[Order Number] and #[Flexit];
 - Each client is eligible to post multiple share banners of their winning intraday trade.
- Provide Vantage with their account number upon request to allow verification of the shared information and trade details.

5. Bonus or Reward Structure

- During the Promotion Period, five (5) participants will be chosen at random, and Vantage will double up their profits shown on their share banners up to USD\$30 each.
- Any amounts exceeding the cap amount will be voided and removed. Please refer to the example below:

Profit earned from Intraday trade (USD)	Double profit reward earned from the Promotion (USD)	Total profits (USD)
\$10	\$10	\$20
\$30	\$30	\$60
\$50	\$30 (Capped)	\$80
\$100	\$30 (Capped)	\$130

- In a case where the chosen winner has multiple share banners, and the chosen share banner's profit is lower than the other share banners posted by the winner, Vantage will not be obligated to change the chosen share banner to that of which has the higher profit earned.
- Each participant may only win once at any time during this Promotion Period.
- At the end of the Promotion Period, Vantage will announce the winners via the Telegram group and contact each of the winners privately through Telegram. The winners are required to respond within 3 business days and provide their account number information to Vantage to receive the rewards. Clients who fail to respond within 3 business days may be forfeited from winning.
- The rewards will be credited to the winner's account respectively within 15 business days.

6. Disqualification

Vantage reserves the right to disqualify any participant who:

- Violates any of the Terms;
- Provides false information or engages in fraudulent activities; or
- Engages in abusive trading practice such as churning or suspicious trading activities.

7. Modification and Termination

Vantage reserves the right to amend, suspend, or terminate this Promotion or any of the Terms at its discretion in case of participants' violating any Terms, providing false information or engaging in abusive behaviours. Update or changes will be communicated via email and posted on the website.

8. Local Laws and Jurisdiction

This Promotion is subject to the laws and regulations of Vanuatu. By participating, you agree that any disputes arising from these Terms will be governed by and resolved under the jurisdiction of the courts of Vanuatu.

9. Data Protection and Privacy

By participating, you consent to the collection and processing of your personal data in accordance with our Privacy Policy, which is available on our website.

10. Liability

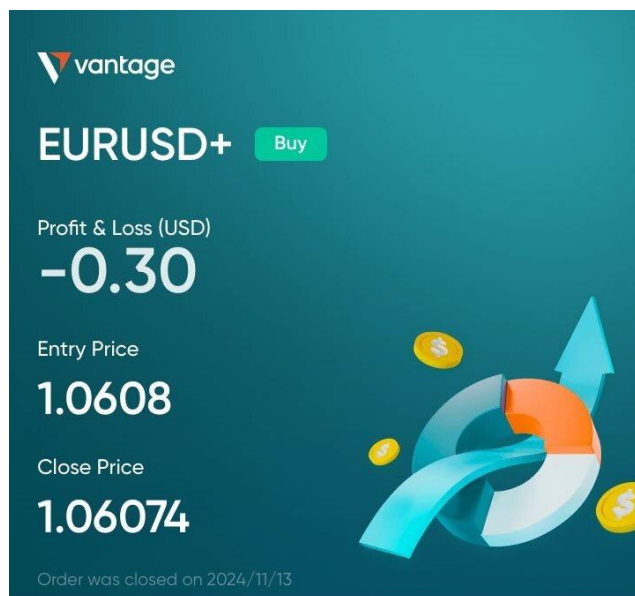

DEFINITIONS

1. **Churning** refers to the practice of opening and closing Margin FX or CFD transactions solely to benefit from promotional offers, rather than executing trades based on sound investment strategies.
